A small business must be on this list and have maintained "Qualified" status to be eligible for consideration of a Qualified Investment by a Qualified Investor. The Cabinet for Economic Development does not perform financial screening or due diligence on the companies listed here and limits its certification to the statutory parameters for a Qualified Small Business. Refer to the Kentucky Angel Investment Act Program Fact Sheet for information on Qualified Small Business eligibility criteria.

The Qualified Small Business designation applies only to the Kentucky Angel Investment Act program. Firms on this list may or may not qualify as a small business for other programs with differing small business criteria.
